
Overseas Sales Ratio (excl. Liquor tax)












Net Sales- Food & Soft Drinks




Net Sales- Restaurants








Operating Income & OP Margin-Restaurants






Cash Flows from Operating Activities




Cash Flows from Investing Activities




Cash Flows from Financing Activities




