# **Group Structure Reorganization**

### 1. Alcoholic beverages business in North America

On April 1, 2020, the following subsidiaries will be transferred from Sapporo Holdings Limited to Sapporo Breweries Limited in order to facilitate the implementation of a unified global brand strategy that will accelerate the global expansion of the Group's alcoholic beverages business.
